Upcoming Caltrans Night Paving Work on East 14th Street – Thornton Street to 136th Avenue (staff report attached)

- The Engineering and Transportation Department has been notified by Caltrans of paving work to be done on East 14th Street between Thornton Street and 136th Avenue starting on the evening of May 25. Subject: **UPCOMING CALTRANS NIGHT PAVING WORK ON E. 14th STREET - THORNTON STREET TO 136th AVENUE**

SUMMARY AND RECOMMENDATION

This report provides information regarding the night paving work to be done by Caltrans on E. 14th Street between Thornton Street and 136th Avenue starting on the evening of May 25, 2012. This is for information only, and no action is required.

BACKGROUND AND DISCUSSION

On May 9, 2012, Engineering and Transportation Department staff was notified by Caltrans of paving work to be done on E. 14th Street between Thornton Street and 136th Ave. This is not associated with another Caltrans paving project scheduled to start this summer for the segment of E. 14th Street between Davis Street and Thornton Street.

Not much information was provided with the initial email notifying the City of this road rehabilitation work, but subsequent conversations with the Caltrans project manager revealed that construction will include removal and replacement of 3-inches of asphalt concrete pavement on the southbound lanes only.

City staff was not given any firm information on the construction schedule until Caltrans notified the City on the morning of May 18, 2012 that the road rehabilitation work will start around 10:00 p.m. on the evening of Friday, May 25th and will be completed by the morning of May 26th around 9:00 a.m. The striping and traffic loops will be reinstalled approximately a week later. Caltrans will work on one southbound lane at a time to minimize impact to traffic.

Caltrans will post lighted changeable message signs by Tuesday, May 22nd to notify the public of this paving work. Please see below for contact information of key project staff.

Subject: **LES SCHWAB TIRES NORTH COAST SECTION BOYS DIVISION I
GOLF QUALIFICATION**

SUMMARY AND RECOMMENDATION

This report is for information only, and no action is required.

BACKGROUND

Each spring, since 1972, the California Interscholastic Federation (CIF) North Coast Section Boys Golf Team Qualification and Championship is contested at various golf facilities around the Bay Area. High school boys golf teams throughout Northern California participate in the qualification and then in the championship. Last year, Foothill High School in Pleasanton was crowned champion, and William Brueckner of Acalanes High in Lafayette was low medalist.

DISCUSSION

This year, the Les Schwab Tires North Coast Section Boys Division I Golf (NCS I Golf) Qualification was held on May 7th on the Tony Lema golf course at Monarch Bay Golf Club. A total of 18 teams and another 31 individual players participated in this year's event. Each team consists of six players with scoring of the top five players. The low team this year was Amador Valley High School with a score of 368. Runner-up was Monte Vista High School, posting a score of 370 and in third was De La Salle High School with a score of 372. Tied for low medalist, with a score of 70 were William Brueckner from Acalanes, Sam Richardson of Amador Valley, Justin Paglia from De La Salle, and Henry Cassriel of Miramonte. Brandon Dizon of San Leandro High School carded a 76, which was low enough to qualify to play in the NCS I Golf Championship. The top nine schools, along with the top 12 individuals, will play in the NCS I Golf Championship to be played on May 14th at Castlewood Country Club. It should be noted that the Championship was held at Monarch Bay in 2001.

CONCLUSION

The Public Works Department and American Golf continue to grow the game of golf by hosting various junior golf competitions and golf camps at Monarch Bay on an annual basis. Other junior events include the San Leandro High School Girls Fall Golf Classic which is played every September, the San Leandro High School Boys Spring Golf Classic, which is played every March, and the San Leandro City Junior Golf Championship which takes place each August. This year, over 900 juniors will have participated in these events and golf camps.

Subject: TWO TRAFFIC SAFETY EDUCATION PROGRAMS FOR SAN LEANDRO HIGH SCHOOL AND 13 K-8 SCHOOLS

SUMMARY AND RECOMMENDATION

Engineering and Transportation Department has secured two separate Safe Routes to School grants to conduct traffic safety education programs for San Leandro High School and 13 K-8 schools. This report is for information only, and no action is required.

BACKGROUND AND DISCUSSION

Program 1. Traffic Signal & Safety Education Program at San Leandro High School

With the support of the San Leandro Unified School District, City staff applied for a grant under the State-Legislated Safe Routes to School (SR2S) Program Cycle 9 in 2010. The City was awarded a grant of \$421,245 for its \$468,050 project by the Department of Transportation (Caltrans).

In response to community concerns about pedestrian and bicyclist safety and traffic congestion at the Bancroft Avenue and 136th Street intersection due to the development of the new 9th Grade Campus of San Leandro High, a project to install a traffic signal at the intersection using the grant funds will be undertaken during the summer of 2012.

The new traffic signal consists of bicycle detection and scrambled pedestrian signal phasing, which offers an exclusive pedestrian signal crossing period, signing, striping, and curb ramps. The grant funds also include \$30,500 for a traffic safety education program for both students and the general public. The program will include workshops to teach attendees best practices for traffic safety behavior. The workshops will also encourage the use of alternative modes of transportation to decrease traffic congestion near school sites, creating a safer environment for students and residents.

The San Leandro High School Traffic Safety Education Program will commence in May 2012 and conclude in Fall 2012 to refresh returning students and include new students.

Program 2. Traffic Signal & Safety Education Program for 13 K-8 Schools in San Leandro

Staff applied for a grant under Cycle 3 of the Safe Routes to School (SR2S) Program to conduct school traffic safety education program at 13 K-8 schools in San Leandro. The City was awarded \$410,000 from this State grant, including \$375,000 for a consultant to conduct the traffic safety program and \$35,000 for staff time.

A multifaceted approach will be used to accomplish the goals of educating elementary and middle school students about pedestrian and bicycle safety and the benefits of using various modes of transportation for commuting to and from school. Workshops will be conducted for students in each grade level (K-8) at ten (10) elementary and three (3) middle schools. Students will participate in demonstrations that teach the effectiveness of bicycling and walking as modes of locomotion and the benefits of decreasing air pollution, making the community safer, and getting physically fit. The program will also address perceptions and reactions to hazards created by vehicles. Students will perform in role playing exercises consisting of bicyclists, pedestrians, and drivers to simulate “real-life” traffic conditions and hazards.

This traffic safety education program will start in September 2012 and end in May 2015 to reach as many students as possible.
