## **ACTIVITY RULES**

- 1. NO PEOPLE are allowed in the pool with dogs at any time.
- 2. Users of the facility do so at their own risk. Owners are solely responsible for the actions of their dog and any damages caused by their dog while at the facility. The City of San Leandro is not liable for any injury or death of any dog or damage caused by any dog in the facility.
- 3. All dogs must be healthy, fully vaccinated with current license tags attached to collar, over 4 months old and not in heat.
- 4. Dogs must be supervised by their owner and under voice control at all times. Vicious and aggressive dogs are NOT allowed. Dogs and owners will be dismissed from the facility IMMEDIATELY at the first sign of aggression towards people or other dogs. Owners are responsible for all pet actions.
- 5. All dogs must enter and exit the pool facility on a leash. Collars with identification must be worn while swimming. Inside the pool facility, an owner must carry leashes at all times and remove choke, pinch or pronged collars with the leash.
- 6. Dogs are the only animal allowed and no more than two dogs per owner are permitted.
- 7. Owners are responsible for clean-up after their dog(s).
- 8. Owners use the facility at their own risk. The City of San Leandro is not responsible for any injury or illness to dogs, their owners or visitors of the facility.
- 9. Alcohol, smoking, and food (dog or human) are not allowed.
- 10. Bicycles, strollers, skateboards, scooters, wagons, glass containers, and dog toys are not allowed.
- 11. Dogs must be accompanied and controlled by an owner that is 18 years of age or older. If you bring a child, you must keep that child with you at all times and closely supervise them. Owners must be present and with their pets and children at all times.

## **Release of Liability**

I understand that water may carry disease or waste from dogs entering the pool and should not be considered safe for humans to enter. To the fullest extent allowed by law, I agree to hold harmless the City of San Leandro, its elective and appointed boards, commissions, officers, agents, employees, and volunteers, from any liability, loss, cost or expense (including, but not limited to, attorney's fees, medical and ambulance cost) that I and/or my dog(s) may incur, including but not limited to injury, sickness or death, while participating in this recreation activity.
